1. Details of the resolutions are set out in the supplemental circular of the Company dated 7 May 2020 (the “*Supplemental Circular*”). For the avoidance of doubt, should the proxies being appointed to attend the AGM under each of the Original Proxy Form and/or the Supplemental Proxy Form are different and more than one of the proxies attended the AGM, only the proxy validly appointed under the Original Proxy Form shall be designated to vote on all the resolutions at the AGM.
